The information CMP submitted on September 18, 2019, has been incorporated it into the record pursuant to the Fifteenth Procedural Order. I have reviewed the material contained in the Supplemental Information for the Merrill Strip Alternative that accompanied the Petition to Reopen the Record. I am requesting additional information in order for the Department to complete its review of this new proposed route segment. Bill Hinkel of the Land Use Planning Commission has also requested a subset (item #1 and #6 below) of the additional information requested below. Please provide the following items:

1. Eight paper copies of the petition and supplemental information for the Merrill Strip alternative. Please send four copies to the Department and four copies to the Commission.
2. A viewshed map depicting areas of potential visibility of the Merrill Strip Alternative.
3. A revised table for wetland impacts for Segment 1 and the corresponding changes to the compensation plan.
4. Project plans with contour lines .
5. Project plans showing any areas that contain slopes in excess of 20% where additional erosion control measures may be needed.
